"THANKS FOR 'NAVIGATING THE RIVERS' WITH THE VAFP"

I think everyone – especially right now - can use a bit of good news...

You may have heard of an analogy to population healthcare – it's like water following in a river. When healthcare needs are manageable – highly satisfying, efficient, safe and effective - the river flows freely, with little turbulence or risk to those navigating in the rafts and canoes – our teams. The highly experienced river guides piloting a craft in the river leads teams safe from point to point.

I think we can agree – presently - healthcare is, however, not serene. It is rather high flow and high turbulence. I think we can also agree not every proposed river guide leading a raft or canoe is a highly experienced river guide, nor is every craft safe, nor does everyone on those teams have effective paddles. Some are ending up in the river, at risk of drowning. Additionally, the dams and canals around them are not enough to control flow for safe river travel.

My message is that this year, your VAFP is providing opportunity for safer healthcare river travel, through:

- Better communication among river guides on how to navigate a turbulent river.
- Providing virtual floatation devices for those who may end up in the water.
- Ensuring high quality river guides are piloting the rafts and canoes.
- Ensuring those responsible for the dams and canals understand that highly experienced river guides those who know the way of the river are needed to best control the flow

How is the VAFP helping to better communicate turbulent healthcare river navigation?

- Your VAFP Winter Meeting in Wintergreen Resort was an absolute success! With high numbers of attendees, record numbers of residents and medical students, our topics were highly practical and relevant, speakers were well received, and perhaps most importantly, many wonderful moments were made possible to connect with one another, in the ways of the river. Thank you to everyone who attended and contributed. We have many expert river guides among us.
- A new VAFP Program Director list serve is allowing networking among our residency programs on issues of mutual need and interest. In the "high class rapid" section of our rivers, the residency programs are often those most at risk, and yet are often those most isolated to find solutions. In addition to a list serve, we are working to support moments when program

leadership can gather and develop more input for VAFP support for helping with our next generation of highly experienced river guides, and to reduce the risk of the high class rapids these programs navigate.

- We are seeking input in all committees, from all parts of our rivers, including those Family Physicians in rural locations and tough to find far Southwest Virginia, to better speak to the full experience of us river guides. We do not know the rivers in all parts of Virginia, but really need and want to.

How is the VAFP helping to provide virtual floatation devices for those who may end up in the water?

- Our new Wellbeing Committee has surveyed our membership, is analyzing the results and will soon be providing specific recommendations to the VAFP Board.
- This feedback will be prioritizing our efforts in further ways to help each of us, and our teams remain out of the water. For those responding to our Wellbeing Survey – thank you. If you see more surveys on this in the future, please do your best to share your perspectives.

How is the VAFP helping to ensure that highly experienced river guides are piloting the rafts and canoes?

- The VAFP "Choose Virginia" conference for medical students to showcase our Virginia Family Medicine residencies is being resurrected this year. All programs have been encouraged to bring faculty and residents to show "hands on" what family medicine is about. The response has been tremendous from all Virginia medical schools and residencies. We all need future river guides, and this opportunity is to see if we can have them gain their high level of experience on Virginia's rivers.
- With VAFP Legislative Committee, we have had several successes at the Capitol this year. Family Physician of the Day involvement, along with a small but mighty Advocacy Day event in Richmond, saw increases in relationships being built for our very clear messages river guides do not get paid enough to stay navigating turbulent rivers, we do not want to be responsible for supervising ill prepared river guides, nor too many of them, and we do not need to be distracted by paperwork and more turbulence when attempting to navigate.



MEMBERS VISIT LEGISLATORS DURING THE VAFP ADVOCACY DAY – JANUARY 19, 2023

VAFP members participated in the VAFP's Advocacy Day to voice support for primary care in the areas of scope of practice, immunizations, and increased reimbursement in the Virginia Medicaid program.

VAFP Legislative Committee Chair Jesus Lizarzaburu, MD testified during the House Health, Welfare, and Institutions Sub-Committee #3 in support of continuing the current statute, a 5-year requirement for supervision of a nurse practitioner before applying for independent practice. He noted the importance of health professionals working collaboratively as clinically integrated teams in the best interest of patients and VAFP's support of physician-led teambased care that addresses patients' needs for high quality, accessible health care that reflects the skills, training, and abilities of each of the health care team members to the full extent of their state-based licenses.

VAFP Member Hailey Sparacino, DO also testified during the same sub-committee in support of HB1573 which directs each health regulatory board within the Department of Health Professions to amend its licensure, certification, and registration applications to remove any existing questions pertaining to mental health conditions and impairment.

VAFP members spoke with individual legislators about the Academy's continued support of the 2020 VAFP sponsored HB1090 (Delegate Patrick Hope) that requires children to be immunized in accordance with the Immunization Schedule developed and published by the Centers for Disease Control and Prevention (CDC), Advisory Committee on Immunization Practices (ACIP), the American Academy of Pediatrics (AAP), and the American Academy of Family Physicians (AAFP).



"Choose Virginia" Scholarships for Graduating Medical Students and Family Medicine Residents

The Virginia Academy of Family Physicians (VAFP) Foundation is delighted to offer a medical student scholarship and a resident scholarship for assistance with education loan repayment. Many medical students and family medicine residents in Virginia have expressed an interest in staying in Virginia after their graduation to complete a family medicine residency or to practice in a medically underserved area. Over the past two years the VAFP Foundation has received donations to support this effort to keep our own.

This year the Foundation will offer one graduating Virginia medical student a \$1,500 scholarship. The successful candidate will meet the following criteria:

- Graduating Virginia medical student in good academic standing.
- Entering a Virginia family medicine residency program. A letter from the program director is required.
- Will have completed the PGY-1 year successfully and be entering into the PGY-2 year at that program. A letter from the program director is required in order to receive the scholarship check for loan repayment at that time.
- Must submit a 250-500 word letter explaining why he/she wants to practice family medicine in Virginia as a resident and as a family physician.

In addition, we are offering one \$2,000 scholarship for a graduating PGY-3 Virginia family medicine resident who wishes to practice in an underserved area of Virginia. The requirements for this scholarship are as follows:

- Graduating as a PGY-3 Virginia family medicine resident
- Have an up-to-date Virginia medical license.
- Practicing family medicine in an underserved medical area after graduation as designated by United States Human Resource Service Administration (HRSA) and/or Virginia Department of Health. A letter verifying this is required.

• Must submit a 250-500-word letter explaining why they he/she wants to practice in an underserved area of Virginia.

• Practicing at the underserved site for one year. Documentation is necessary to receive the scholarship check for loan repayment after one year of practice in an underserved area.

racial and ethnic groups underrepresented in medicine, as well as from rural communities,



ATTENTION – MEDICAID MANAGED CARE AND FEE-FOR-SERVICE PARTICIPATING PHYSICIANS

In accordance with the federal 21st Century Cures Act, over the last several months, the Department of Medical Assistance Services (DMAS) and its managed care plans have been notifying providers to enroll as a provider directly with DMAS through the Department>s Medicaid Provider Services Solution (PRSS) enrollment portal.

IMPORTANT DEADLINE FOR MANAGED CARE NETWORK PROVIDERS

Effective April 1, 2023, Virginia Medicaid MCOs will be prohibited from paying network providers until the provider is enrolled with the DMAS through the PRSS portal. Two Action Items:

- 1. Enroll all National Provider Identifier (NPI) numbers in PRSS for all servicing, billing, ordering, referring, or prescribing providers.
 - Providers should initiate their enrollment application in PRSS, via virginia.hppcloud. com now to avoid disruption to claims payments.
 - Only one enrollment application per NPI/service location is necessary in PRSS, even if a provider participates with more than one MCO.
 - Providers with multiple National Provider Identifier (NPI) numbers must enroll *all* of their NPIs in PRSS.
 - Providers with multiple service locations must enroll all service locations.

PHYSICIAN SERVICE

• MCO network providers who have already enrolled all of their NPIs and all of their service locations with Medicaid fee-for-service do not need to re-enroll in PRSS. Providers who are not certain if all NPIs and service locations are enrolled should verify their enrollment status in PRSS (see #2 below).

2. Check your PRSS enrollment status

- DMAS has posted a spreadsheet that lists all active, PRSS enrolled Virginia Medicaid providers.
- Providers should check their enrollment status for all NPIs and service locations before enrolling in PRSS, including for servicing and billing providers and also for nonbilling NPIs, including ordering, referring, and prescribing providers.

FAMILY PHYSICIANS WILL PLAY CRITICAL ROLE IN PHE UNWINDING

Why it matters:

President Biden announced that the public health emergency will end May 11. This will trigger the end of many emergency waivers and flexibilities that physicians, patients, and other stakeholders have become accustomed to. While the AAFP has been expecting and preparing for the end of the PHE, we're committed to working with federal policymakers and our members to ensure the smoothest possible transition.

What AAFP is working on:

The AAFP wrote to President Biden urging the administration to publish a comprehensive plan for unwinding the flexibilities and waiver authorities available under the PHE, and to use its authority to minimize disruption. This includes

- protecting equitable, affordable access to COVID-19 vaccines, treatments, and testing;
- ensuring that physician practices can purchase and stock COVID-19 vaccines once they transition to the commercial market;
- preventing Medicare telehealth coverage and payment disruptions;
- protecting patients' access to lifesaving opioid use disorder treatment via telehealth;
- removing administrative, cost, and other barriers for individuals with long COVID seeking the health care services and federal assistance they need; and
- permanently expanding Medicare resident supervision flexibilities.

AAFP SHARES WORKFORCE RECOMMENDATIONS WITH SENATE HELP COMMITTEE

Why it matters:

Primary care is the only health care component for which an increased

supply is associated with better population health and more equitable outcomes. Despite the significant role that primary care plays in our health system, primary care accounts for a mere 5% to 7% of total health care spending.

We have seen growth in the number of medical students choosing family medicine, but the increase will not be enough to meet the projected need. We will need up to 48,000 additional primary care physicians by 2034. The AAFP has long advocated for policies that target and invest in the primary care workforce to meet the diverse needs of our growing and aging population.

What AAFP is working on:

The AAFP submitted testimony for a Feb. 16 Senate HELP Committee hearing that examined health workforce shortages and solutions to mitigate this troubling trend. The AAFP's testimony outlined several recommendations to invest in the primary care workforce, including:

- strengthening and investing in federal graduate medical education programs;
- diversifying the physician workforce;
- addressing the burden of medical student debt;
- supporting physician-led, teambased care and the integration of behavioral health and primary care;
- enacting telehealth policies that extend the capacity of our health care workforce; and
- stopping anti-competitive contracting practices that harm clinicians and patients.

AAFP ENDORSES KIDS' ACCESS TO PRIMARY CARE ACT, ADVOCATES FOR MEDICAID PARITY

Why it matters:

The AAFP has endorsed the Kids' Access to Primary Care Act, which would help raise Medicaid payment rates for primary care services to at least those of Medicare. We have long advocated for legislation that would fix inadequate Medicaid physician payment to ensure patients in need have equitable and timely access to needed health care services. Nationwide, Medicaid pays an average of 66% of the Medicare rate, with some states paying as little as 33%.

AAFP CHAMPIONS POLICIES TO ADDRESS SUD

Why it matters:

Family physicians and other primary care clinicians are on the front lines of the opioid and overdose epidemics. The AAFP has long urged Congress and the administration to remove barriers for physicians prescribing medication for opioid use disorder. Among the numerous AAFP advocacy wins in the Consolidated Appropriations Act of 2023 was the elimination of the X waiver — an administrative hurdle the Academy had steadily opposed — that was worsening barriers to substance use disorder treatment. Additionally, new data continue to illustrate that primary care physicians are playing an increasing role in addressing patients' mental health concerns.

What AAFP is working on:

The AAFP wrote to HHS in support of proposed regulations to streamline requirements governing substance use disorder treatment confidentiality in order to facilitate care coordination.

The AAFP submitted comments to the Substance Abuse and Mental Health Services Administration supporting proposals to permanently enable opioid treatment programs to provide substance use disorder treatment via telehealth in certain circumstances and urging the Drug Enforcement Administration to make similar changes for all physicians.

The AAFP remains committed to advancing key pieces of the

administration's Unity Agenda by ensuring that primary care physicians have the resources they need to not only provide mental health care to patients but also lead effective and coordinated care teams with other mental health professionals. This includes appropriate payment, upfront funding, accessible and timely health IT updates, and a sufficient behavioral health workforce.

AAFP SUBMITS COMMENTS ON MEDICARE ADVANTAGE PRIOR AUTHORIZATION RULE

Why it matters:

This proposed rule is an important first step in improving access to behavioral health services in Medicare Advantage and recognizing and reducing the administrative burdens and barriers to care imposed by prior authorization. If finalized, new prior authorization regulations would improve Medicare Advantage clinical coverage policies and reduce inappropriate care denials; however, additional reforms are needed to address the overwhelming volume of prior authorizations and ensure that patients have timely access to care.

What AAFP is working on:

The AAFP urged CMS to finalize proposals strengthening Medicare Advantage network adequacy requirements for behavioral health services, improving transparency of coverage criteria and medical necessity determinations, and protecting enrollees' equitable access to basic Medicare benefits.

The AAFP also recommended that CMS strengthen the proposed rule by expanding new clinical coverage requirements to prescription drug coverage and implementing guardrails to reduce the overall volume of prior authorization requirements in Medicare Advantage.

The AAFP has repeatedly called for streamlined prior authorization to alleviate physician burden and address care delays. We will be providing comprehensive comments on a related proposal to automate prior authorization processes across payers by 2026.

AAFP'S ROBERT GRAHAM CENTER AUTHORS NEW PRIMARY CARE SCORECARD

Why it matters:

The AAFP's Robert Graham Center authored the first national primary care scorecard, co-funded by the Milbank Memorial Fund and the Physicians Foundation. The scorecard finds a chronic lack of adequate support for the implementation of high-quality primary care across the United States.

This scorecard was developed in response to the challenge issued in a National Academies of Science Engineering and Medicine 2021 report calling for an annual tracking tool to measure improvements in the implementation of high-quality primary care over time.

Informed by the NASEM recommendations and an advisory committee of key stakeholders, the scorecard measures key primary care indicators over the past decade and reveals the urgent need for policies to improve a primary care infrastructure in crisis.



IN MEMORIAM VAFP Past President Dr. George R. "Bob" Smith Jr. 1927-2023



Dr. George R. "Bob" Smith Jr., passed away on February 18, 2023, at the age of 96. Bob and his wife, Mildred, stopped in Shawsville, Virginia in 1954, when he was in his last year of residency at Medical College of Virginia, and asked if the town needed a doctor. The rest is history or perhaps divine intervention. After a stint in the U.S. Navy, Bob attended the University of North Carolina and Harvard Medical School. Although forever loyal to those organizations, he gave generously to Virginia Tech for the rest of his life. Go Hokies! Notwithstanding his "Harvard" skills, Bob was most proud of his "country doctor" credentials, founding the Alleghany Clinic in 1955, and welcoming Dr. C.W. Taylor, Jr., to the practice in 1957. He worked tirelessly throughout a 42-year career as a family physician, during which time he commonly made house calls, delivered babies, and conducted countless

free-of-charge physicals for local high school athletes. While he appreciated his peers' praise, having been elected to lead several prominent organizations and awarded more accolades than his humbleness would allow us to list, Bob was most proud of the many patients whose lives he personally touched throughout Shawsville and the surrounding counties. Dr. Smith served as the Virginia Academy of Family Physicians President from 1977-78.
