As the 78th President of the Virginia Academy of Family Physicians (VAFP), it is my honor and privilege to serve you, the Family Physicians of Virginia, for the upcoming year. Over the years I've served our academy, I can recall several highlights:

- Partnering with former colleagues at the American Cancer Society to ensure plans and insurers cover a follow up colonoscopy for a positive stool-based screening test
- Increasing Medicaid payments for primary care
- Protecting our medical malpractice cap
- Improving immunization coverage for Virginians
- Decreasing administrative and prior authorization burden
- Developing policies to help alleviate the number of unnecessary refill requests we receive from pharmacies
- Improving resident teaching environments by engaging with policymakers and insurers to streamline competency-based supervision requirements
- Successfully advocating against scope creep from other health professionals

There is no better specialty than ours. Our specialty leads in decreasing healthcare costs, improving mortality rates in various settings, adding days of life to communities we care for, and adapting skillfully to positively impact the care of our patients. Our community impact factor is unquestionable. As the reliable, holistic first contact for patients, there is no better specialty for the undiagnosed undifferentiated patient to come see.

Supporting our members to continue to practice in this manner is imperative and we are with you.





Ms. R's daughter messages me through the portal that her 80 year old mother with mild dementia and frequent UTIs is still not getting better after the round of antibiotics I called in for her last week. She is falling, no longer vomiting but has no appetite, complains of persistent dizziness. Her head CT showed no bleeding from when she hit her head last week. Her urine culture was negative but she did have an elevated white count and new transaminitis. She has had multiple recent hospital admissions and always deteriorates when she is in the ER. Her complaints are vague, she's medically complex, her daughter is worried. I straddle that uncomfortable fence of inadequacy. I don't feel like she needs the ER right now. I'm unsure about those lab abnormalities. I'm hesitant to order more imaging if I'm not sure what I'm looking for. Clearly, I should know what to do. Obviously, I'm not skilled enough. Who am I kidding?

Despite the years of training and countless successful patient interactions, many of us family physicians experience imposter syndrome. This psychological phenomenon describes a nagging feeling of intellectual and professional inadequacy despite objective evidence of competence. Medicine is complex and grows more so every year, there is no way we can keep up with all the developments in oncology or cardiac electrophysiology. Our patients come to us first (and back again after making a circuit of specialists) and the answers to their ailments are not always clear on the first pass. Because of our dedication and the comprehensive nature of the care we give, we are susceptible to the demoralizing thought patterns of imposter syndrome.

Imposter syndrome manifests in several ways. Some physicians downplay our achievements, attributing success to luck or external factors. We might doubt our diagnostic skills, fearing we'll miss a crucial detail. This constant selfdoubt can lead to excessive work hours and neglecting personal needs in pursuit of perceived perfection. We may feel uncomfortable accepting praise, seeking approval from others, holding ourselves back from our goals. We over-prepare, we take on more tasks to prove our worth, we chase perfectionism. The pressure to excel can contribute to burnout, expressed as cynicism, decreased fulfillment in our jobs, and withdrawing from full practice.

We can combat imposter syndrome by building a foundation of confidence and then practicing whenever that inner negative voice pipes up.

Recognition: Imposter syndrome is common, it's not just us in medicine. Recognize when your thoughts are turning to a cycle of worry, self-doubt, and fear. Openly discuss this fear of not being good enough with colleagues. Sharing our experiences fosters a sense of community and demonstrates that even accomplished physicians grapple with self-doubt. Join local physician groups,

VAFP meetings, sign up for PeerRxMed (www.peerrxmed.com). Call out that inner narrative when you find yourself judging yourself harshly, putting yourself down, or drawing yourself back and then re-frame those thoughts: How would someone who has never felt imposter syndrome respond with humility in this situation?

Celebrate Success: Intentionally celebrate successes in patient outcomes. High five the patient who has dropped her AIC 1%. Share your published article with your family, colleagues, and clinics. Bask in the positive feedback our patients and colleagues drop on us daily and blow aside that one passive aggressive comment. Highlight others on your team that are also doing good work.

Practice Accepting Praise: Many of us have been cultured to be humble and don't feel comfortable with compliments. Receiving feedback, even positive feedback, can feel like opening ourselves up to judgement. However, we do good strong work and play a valuable role in people's lives. Accepting praise is one way to practice self-compassion. How would you want your best friend to take your compliment? Surely not with a shrug, deflection, or embarrassment. Just say "thank you", to start. Perhaps share what that compliment means to you. We can accept praise humbly without putting ourselves down. Don't feel obligated to reciprocate, instead thank them for the notice. "Thank you. I feel honored to be recognized among so many of my deserving peers. I'll be sure to share your congratulations with the team that helped create this win!"

Don't Compare Yourself to Others:
Each of us practices medicine and relates to our patients with different styles. We are as diverse as our patients and their health conditions. We derive joy in different aspects of the care we provide. We have different goals and daily choose different paths to walk. Because medicine is complex, some of us will have stronger backgrounds in different areas of family medicine and none of us know it all.

Accept Uncertainty: Medicine is a discipline built on the foundation of knowledge and evidence, yet uncertainty

is its constant companion. We are often expected to provide definitive answers and solutions, and the complexity of human biology and the ever-evolving landscape of medical science necessitate a degree of acceptance of the unknown. Acknowledging uncertainty is not a sign of weakness, but rather a testament to a commitment to providing the best possible care. By openly discussing limitations and exploring various possibilities with patients, we can foster trust and create a collaborative approach to guide our patients, ultimately leading to better outcomes. Keeping uncertainty in our differential reminds us that not everyone is expected to know everything and that not knowing does not make us an imposter.

Prioritize Self-Care: Prioritizing self-care, including healthy work-life balance, fosters emotional resilience and reduces the negative effects of self-doubt. Doing acts that demonstrate we value ourselves re-trains our narrative to put trust in our analysis and decision-making. Such practices can erode the self-doubt and self-criticism that define imposter syndrome.

We graduated medical school and passed our boards. We learned the basics we need to know and have the skills to continue to learn and improve as we practice daily.

I message Ms. R's daughter as she is vigilant on the portal: "I'm not sure what the next best step is. It would not be wrong if you think she is worsening to take her to the ER. For now, let's watch her closely. Let's recheck her labs in two weeks. I've run her story by my colleague, and he agrees this is a tough spot. Let's focus on keeping her hydrated and pushing gentle nutrition. Let me know if you notice something new or different."

residents in Virginia have expressed an interest in staying in Virginia after their graduation to complete a family medicine residency or to practice in a medically underserved area. Over the past few years the VAFP Foundation has received donations to support this effort to keep our own.

Virginia Medical Student – \$2,500 Scholarship

The successful candidate will meet the following criteria:
1) Graduating Virginia medical student in good academic standing

- 2) Entering a Virginia family medicine residency program. A letter from the program director is required.
- 3) Will have completed the PGY-1 year successfully and be entering into the PGY-2 year at that program. A letter from the program director is required in order to receive the scholarship check for loan repayment at that time.
- 4) Must submit a 250-500 word letter explaining why they want to practice family medicine in Virginia as a resident and as a family physician.

Graduating PGY-3 Family Medicine Resident – \$3,000 Scholarship

The requirements for this scholarship are as follows:
1) Graduating as a PGY-3 Virginia family medicine resident

- 2) Have an up-to-date Virginia medical license
- 3) Practicing family medicine in an underserved medical area after graduation as designated by United States Human Resource Service Administration (HRSA) and/or Virginia Department of Health. A letter verifying this is required.
 4) Must submit a 250-500-word letter explaining why they want to practice in an underserved area of Virginia
 5) Practicing at the underserved site for one year.
- Documentation is necessary to receive the scholarship check for loan repayment after one year of practice in an underserved area.



A Day in the Life of a CenterWell Physician

Working at CenterWell Senior Primary Care provides professional satisfaction and personal life balance. As a physician, the supportive team environment and resources empower me to deliver exceptional patient care while maintaining a healthy work-life mix.

Setting Myself Up for Success: My Morning Routine

My day begins early with a grounding routine consisting of meditation and a short prayer that sets a positive tone for the hours ahead. This practice helps me get centered so that I can focus on treating my patients with the compassion and respect I would want for my own family. I then spend quality time with my wife, preparing us a healthy breakfast.

Starting the Workday the Right Way

I'm usually the first to arrive at the clinic, appreciating the quiet time and preparing for the day ahead. With a cup of coffee in hand, I review my patient list, considering each individual's needs and the type of visit planned—whether it is a new patient, follow-up or acute visit. This preparation allows me to focus on specific issues and set clear intentions for each appointment.

Our day officially starts with a huddle from 8 to 8:20 a.m., during which the care team discusses each patient scheduled for the day. Our nurse practitioner, medical assistants, front office staff, center administrator, referral coordinators and I are all engaged to ensure we are aligned and prepared to provide top-tier, comprehensive care. We discuss everything from medical issues and transportation arrangements to prescription drug assistance, mental health assessments and chronic disease management, which helps streamline our workflow and enhance patient experiences.

A Day Filled with Patient Care

At 8:30 a.m., I start seeing patients, spending up to 50% more time with each individual than a typical provider's appointment. This extended time allows me to address not only medical concerns, but also any social issues that may significantly impact their health and well-being. I enjoy these indepth conversations, learning about my patients' lives, aspirations and challenges. This holistic approach fosters strong relationships and trust, which are critical for effective care.

Collaboration with my care team and medical assistants is a cornerstone of our success at CenterWell. For instance, our care integration team plays a crucial role in transitional care, contacting patients discharged from hospitals within two days and scheduling follow-up visits at our center.

This proactive approach has led to positive outcomes, such as connecting patients with community resources to address food insecurity and financial challenges.

Stress-Free Downtime and a Timely "Close-Out" When I have downtime between patients, I use it productively by reading about medical conditions, answering team members' questions or preparing for upcoming appointments. I also have time throughout the day to finish patient documentation before I leave the clinic, allowing me to leave work at work. The advanced technology and EMR systems help facilitate this, further saving time that I can then dedicate to patient care and follow-ups.

Maintaining a work-life balance is a priority for me, and CenterWell's model supports this. The manageable patient panel and control over my schedule and patient visit frequency allow me the autonomy to address non-urgent issues in subsequent visits, ensuring thorough and thoughtful care.

This balance is crucial for sustaining the passion and dedication required in my role at CenterWell, and it's a testament to the supportive environment that allows physicians to thrive both in and out of the clinic.



ADULT PSYCHIATRIC ACCESS LINE

The Adult Psychiatric Access Line (APAL) is a statewide consult and care navigation program designed for adults struggling with substance use disorders to access specialized mental health services and prepare primary care and emergency clinicians to support patients' behavioral health needs through trainings and education.

The Problem: Too Few Providers

Despite sizable investments at the state and federal level, Virginia's capacity is constrained across the Commonwealth's continuum of behavioral health care. There are not enough specialized healthcare providers to meet patient demand for behavioral




and mental health services. Virginia faces significant challenges in developing specialized solutions to reduce adverse health outcomes related to substance use disorders.

The Solution: The Adult Psychiatric Access Line

With the support and resources provided by APAL, healthcare providers, particularly those in primary care and emergency settings, will have the tools and knowledge to help effectively diagnose, prescribe, and assist patients in navigating substance use recovery care. APAL's care model is based on three components:

Provider education on screening, diagnosis, management, and treatment of SUDs; access to telephonic consultations via regional hubs comprised of addiction medicine specialists and psychiatrists, psychologists, and/or social workers; and care navigation assistance to help identify additional regional mental health services and resources.

Also, the Academy regularly convened Virginia's Family Medicine residency program directors and associate program directors to facilitate networking and learn how the VAFP can assist them with educating the next generation of family physicians. Thank you to those who participated in the meetings and partnered with the Academy to strengthen Family Medicine residency training in the state.

Wellness is key to maintaining physician joy in practice and sustaining the Family Medicine physician workforce. The VAFP launched a new column in the Academy's spring magazine called the "VAFP Well-being Corner" which highlights potential challenges to physician well-being and provides examples of how physicians can improve their response to these situations. Thank you to the Well-being Committee, led by Neeta Goel, MD and Mark Greenawald, MD, for the incredible work you've done to help members achieve wellness.

To promote practice innovation and transformation, the VAFP piloted the Family Medicine Practice Transformation Grant Initiative. This grant is available to attending and resident physician members to support a project within their practice that enhances the patient experience or supports the delivery of the highest level of care to patients. David Killeen, MD at Neighborhood Health in Alexandria, VA was the winner of the inaugural grant. Dr. Killeen used the grant to expand the prenatal ultrasound services offered at the practice which provided prenatal patients with more complete and timely care.

A number of Academy members were selected for leadership positions at the national level. Allison Zamora, a recent graduate of Liberty University College of Osteopathic Medicine - Center for Medical and Health Sciences, was elected as Student Chair of the 2024 AAFP National Conference, Tabatha Davis, MD was elected as New Physician constituency co-convener for the 2025 AAFP National Conference of Constituency Leaders (NCCL) and New Physician Alternate Delegate to the 2024 AAFP Congress of Delegates. Heba Elzawahry, MD was appointed to serve on the reference committee for Organization and Finance for the 2024 NCCL and Richard (Rich) Uribe, MD was appointed to serve on the reference committee for Education for the 2024 NCCL. One Academy member was recognized at the national level for significant contributions to advance community health. Fern Hauck, MD, MS, received the 2024 AAFP Public Health Award for her care of refugee populations in the greater Charlottesville community. Congratulations to all!

As my term as President concludes, I would like to thank the amazing VAFP officers and directors for their service to the organization. Also, thank you to the wonderful and talented VAFP staff for making the Academy a thriving organization. Together, we guided the Academy to represent the interests of Virginia's family physicians. Finally, thank you to VAFP members for giving me the opportunity to lead this great organization. It has been a pleasure to serve Academy members, Virginia's family physicians and patients across the state. The Academy has a bright future ahead, and I hope you will continue to be a part of that journey.

LEGISLATIVE UPDATE

Hunter Jamerson, JD, MBA, General Counsel & Legislative Consultant

The VAFP Legislative Committee Co-Chaired by Jesus Lizarzaburu, MD and Mark Watts, MD, VAFP Legislative Consultant and General Counsel Hunter Jamerson, JD and family physician members of the committee were extremely busy working to advocate on behalf of family medicine in Virginia. The committee meets virtually weekly during the General Assembly and on an as needed basis meets virtually or communicates via list serv outside of the General Assembly. This group is very important to the mission of the VAFP in representing you in the legislative arena to ensure that primary care and specifically issues impacting your daily practice of family medicine are monitored and addressed.

2024 Annual General Assembly Report

The VAFP completed another successful General Assembly session, advocating for the interests of family medicine. This session presented significant challenges in both scope, reimbursement, and professional defense. Through VAFP's advocacy, in coordination with our colleagues in the House of Medicine, the VAFP secured several major victories.

This session also presented an opportunity to introduce the priorities of family medicine to a new group of legislators. More than 60% of the General Assembly was new this year. As a result, VAFP spent a significant amount of time educating legislators who were learning about the challenges facing family medicine for the first time. VAFP sponsored a successful Advocacy Day allowing members to directly connect with their legislators in order to provide a primary resource for the issues facing family physicians practicing on the front lines.

VAFP's 2024 General Assembly Session victories included:

Medical Malpractice

Senator Stanley's SB 493 proposed to eliminate the cap on the recovery in actions against health care providers for medical malpractice where the act or acts of malpractice occurred, on or after July 1, 2024, against a patient aged 10 or younger. After advancing from the Courts Committee on a vote of 8-4 with 3 abstentions, VAFP, in coordination with other stakeholders, was able to defeat the bill on a vote of 6-9 in the Senate Committee on Finance. Threats to the Med-Mal cap remain, however, so an inter-session work group will meet to discuss concerns about the Med-Mal cap and map out possible future reforms.

Nurse Practitioner Autonomous Practice

Delegate Tran's HB 971 proposed to reduce from 5 years to 2 years the post-graduate pathway to autonomous practice for nurse practitioners. It became clear that the votes were not present in either chamber to support a 2 year pathway; however, it was equally clear the votes were not present to hold the current 5 year standard. After substantial negotiations, consensus was reached to reset the pathway to 3 years (the high end of the national average) with the understanding that the issue will not be raised again for the foreseeable future. To help

ensure the longevity of this "deal," a study will be conducted by Department of Health Professions with a report due prior to the 2028 General Assembly detailing how many nurse practitioners sought autonomy, where they chose to practice, and how many disciplinary claims arose against autonomous nurse practitioners.

Joint Boards of Medicine and Nursing

Senator Boysko's SB 351 sought to eliminate the Joint Boards of Medicine and Nursing in favor of nurse practitioners being solely regulated by the Board of Nursing. Presently, nurse practitioners are regulated by physicians and nurses comprising the Joint Boards. In conjunction with other stakeholders, VAFP was able to defeat this bill in the Health Professions subcommittee. The bill failed for lack of a second to the motion to recommend reporting the bill.

Administrative Burdens

Senator Favola's SB 425 significantly improves carrier business practices. The bill prohibits a carrier from imposing any retroactive denial of a previously paid claim or in any other way seeking recovery or refund of a previously paid claim unless the carrier specifies in writing the specific claim or claims for which the retroactive denial is to be imposed or the recovery or refund is sought, the carrier has provided a written explanation of why the claim is being retroactively adjusted. The bill provides that the time limit for a retroactive denial is 12 months; however, a provider and a carrier may agree in writing that recoupment of overpayments by withholding or offsetting against future payments may occur after such 12 month-limit. The bill requires carriers, beginning no later than July 1, 2025, to make available an electronic means for providers to determine whether an enrollee is covered by a health plan that is subject to the State Corporation Commission's jurisdiction. The Governor signed this bill into law.

Prior Authorization

Senator Favola's SB 98 enshrines certain protections for prior authorization approvals. SB 98 requires that any provider contract between a carrier and a participating health care provider contain specific provisions that require that if a prior authorization request is approved and services and supplies have been scheduled, provided, or delivered to the patient consistent with the authorization, the carrier shall not revoke, limit, condition, modify, or restrict that authorization unless (i) there is evidence that the authorization was obtained based on fraud or misrepresentation; (ii) final actions by the U.S. Food and Drug Administration, other regulatory agencies, or the manufacturer remove the drug from the market, limit its use in a manner that affects the authorization, or communicate a patient safety issue that would affect the authorization alone or in combination with other authorizations; (iii) a combination of drugs prescribed would cause a drug interaction; or (iv) a generic or biosimilar is added to the prescription drug formulary. The Governor signed this bill into law.

Looking Ahead

VAFP will continue its zealous advocacy in the General Assembly to support the priorities of family medicine. The VAFP Legislative Committee is presently focused on continued defense of scope of practice, implementation of administrative burden reforms, support for family medicine residency programs, and expanding opportunities for reimbursement in both the public and private payor space. VAFP is especially focused on continuing to work toward Medicare – Medicaid payment parity. In a world of finite resources and competing priorities, your support is more important than ever. 2024 Advocacy Day

On Thursday, January 18, 2024, VAFP members participated in the annual VAFP Advocacy Day at the Virginia General Assembly. The day started with breakfast and a briefing on the issues of interest from VAFP Legislative Consultant Hunter Jamerson, JD. Following breakfast and briefing, the group made their way to the newly opened General Assembly building where they had in person meetings with their respective Senators and Delegates, lobbying on issues pertinent to the daily practice of family medicine and attended health sub-committee meetings in both the Senate and the House. Many of the legislators VAFP members met with during the day were newly elected to the General Assembly which was a great avenue for developing relationships and educating on the importance of primary care in the Commonwealth.

Issues that the family physician, family medicine resident and medical student participants focused on in their discussion with legislators and their aides included the medical malpractice cap, prior authorization, scope of practice, incentives for mental health services, covenants not to compete, health insurance coverages and the importance of the primary care workforce in Virginia. On the state budget front, participants emphasized the importance of the passage of funds to increase the Medicaid reimbursement in primary care and funds for loan repayment to family physicians that choose to practice in a health professions shortage area of the Commonwealth.

Again in 2024, the VAFP staffed the medical station in the General Assembly Building daily from 9:00 a.m. - 3:00 p.m. VAFP members volunteer to work the clinic each day of the legislative session. It is a great way to meet your legislator and continue to have family medicine at the forefront in the minds of our lawmakers.

CONTINUING MEDICAL EDUCATION

The Virginia Academy of Family Physicians continues its tradition of offering first class, affordable continuing medical education conferences for Academy members. The Academy is pleased to report that the 2023-2024 year saw a rebound for attendance at our CME events that mirrors the pre-COVID years. The VAFP CME Committee Chaired by Mitchell Miller, MD, continually works on behalf of family physicians to create events that focus on the most up to date topics that are pertinent to the daily practice of family medicine and national/ state educational requirements.

Each year, the Academy sponsors two major CME activities. The Winter Family Medicine Weekend is held over four days in the month of January. The 2024 winter event was held over the dates of January 25-28 at Wintergreen Resort. It drew over 200 family physicians, residents, medical students, and other health care professionals and 38 exhibiting organizations supported the meeting. The Academy continues to offer a one-time complimentary registration to all AAFP member recent graduates that were less than 5 years out of residency. Thirteen of our new physician members took advantage of this outstanding opportunity.

The Academy's Annual Meeting & Exposition is held each summer in mid-July or early August. This year's Annual Meeting is scheduled for July 18-21 at The Williamsburg Lodge. The meeting will be comprised of two full days and two half days of general CME sessions and workshops worth up to over 20 credits of live AAFP Prescribed CME. Sessions will be in-person at the Lodge. In 2024, the Academy is offering the VAFP Journal Club as a new session that satisfies the ABFM certification requirements. A special thank you to VAFP Past President and Treasurer Charles Frazier, MD for facilitating this inaugural session.

In addition to the VAFP Journal Club, the VAFP also sponsored five Knowledge Self-Assessment (KSA) programs to assist VAFP members with the completion of their ABFM Family Medicine certification requirements. These sessions drew maximum attendance and continue to be evaluated very highly. The facilitation of the KSA's in a hybrid model has truly been a great member benefit as it allows members to feel as though they are in person without having to travel if they so choose.

Continuing in 2024, the VAFP offered at each major CME event an opportunity to attend sessions focused on the management of pain and opioid prescribing that serves to satisfy the MATE act which is a federal requirement for continuing education in pain management, proper prescribing of controlled substances, and the diagnosis and management of addiction. The Drug Enforcement Administration (DEA) and the Substance Abuse and Mental Health Services

Administration (SAMHSA) released materials in 2023 related to the new Medication Access and Training Expansion (MATE) Act. The Act requires new or renewing DEA licensees, to have completed a total of at least eight hours of training on opioid or other substance use disorders and the appropriate treatment of pain.

The Academy partnered with the American Academy of Pediatrics (VA-AAP) and the Virginia Mental Health Access Program (VMAP) on the provision of pediatric mental health education to include live sessions on helping families get the treatment their children need and a webinar on the impact of the internet on youth mental health.

The Academy expresses its deep appreciation to the Chair of the Continuing Medical Education Committee for their outstanding work in creating superb CME for VAFP members and to Kurtis S. Elward, MD, MPH, FAAFP, Mark H. Greenawald, MD, FAAFP, Tarin Schmidt-Dalton, MD, FAAFP, Mary Beth Sweet, MD, and Charles Frazier, MD, FAAFP for their exceptional work as Family Medicine Certification session presenters.

MEMBERSHIP

As of May 2024, total VAFP membership stood at 3,076 with Active membership totaling 1,810, resident membership at 346 and student membership at 509. Four additional categories including Life membership totaled 411. The membership numbers are slightly decreased from 2023 and an area that the VAFP staff is focused on for the remainder of the 2024 membership year. In evaluating the drop in active membership, the New Physician category (graduation from residency within seven years) and those members that are transitioning from the Active Member to Life Member category show the largest decrease. Additionally, our resident members decreased slightly and an area that staff will work with program coordinators to strive for 100% resident membership in the VAFP.

The VAFP continues to offer multiple member benefits including access to the Daily POEMS, the VAFP Career Center and legal resources for employment contract negotiations, regulatory and administrative issues.

Daily POEMs (Patient Oriented Evidence that Matters) from Essential Evidence Plus provide members with complimentary daily alerts and over 3,000 archived POEMs to help members stay abreast of the latest and most relevant medical literature. Delivered directly to by e-mail every Monday through Friday, Daily POEMs identify the most valid, relevant research that may change the way physicians practice. Since 1996, POEMs editors review more than 1,200 studies monthly from more than 100 medical journals, presenting only the best and most relevant as POEMs. The acclaimed POEMs process applies specific criteria for validity and relevance to clinical practice. RESIDENT, STUDENT & FACULTY

The Virginia Academy of Family Physicians puts great focus on our resident and student members and the faculty at the residency programs and medical schools that support the training of these future family physicians.

Resident and Student Leadership

VAFP resident and student members can participate in multiple leadership positions at the state level on the VAFP Board of Directors, as members of VAFP committees and as Delegate to the AAFP National Conference representing Virginia. On the national level, as members of AAFP commissions and other various representatives to partner AAFP organizations. On the VAFP Board, resident and medical student representatives serve a one-year term beginning in the fall of each year. Representatives are funded to attend all VAFP Board Meetings as well as the AAFP's National Conference of Family Medicine Residents and Medical Students held annually in July/August.

Resident and Student Benefits

Academy dues are paid by the VAFP for resident members in their first year of residency and all four years of medical student dues are complimentary.

In addition to membership dues benefits, the VAFP provides complimentary housing for students and residents to attend the VAFP Winter Family Medicine Weekend held annually at Wintergreen Resort. At the 2024 VAFP Winter Family Medicine Weekend, 11 Family Medicine Residents and 36 medical students were in attendance. Continued from previous years, was a resident panel discussion that offered students the opportunity to ask questions of residents related to "What It's Like to be a FM Resident?". At the conclusion of the panel discussion, the residents and students enjoyed a complimentary networking dinner.

The VAFP also supports residents with discounted employment contract review by the VAFP's General Counsel and a Career Center that houses multiple job offerings in the Commonwealth. The VAFP supports the Family Medicine Interest Group's at each of the six Virginia medical schools with \$500.00 in funding to develop programs that promote Family Medicine.

Choose VA Scholarships

The VAFP Foundation offers a medical student scholarship and a resident scholarship for assistance with education loan repayment. Many medical students and family medicine residents in Virginia have expressed an interest in staying in the Commonwealth after their graduation to complete a family medicine residency or to practice in a medically underserved area. The VAFP Foundation receives donations from generous members to support this effort to keep our own. A \$2,500 scholarship is available for a graduating medical student that attends a Virginia Residency Program a \$3,500 scholarship is available for a Virginia PGY-3 Graduating Resident that chooses to practice in an underserved area of Virginia. The Foundation awarded its first scholarships in 2017.

Research

In the fall of 2023, the VAFP hosted a Scholarly Symposium for residents, medical students, and fellows. This one-day event showcased scholarly work in the areas of clinical or population health research, medical education research, literature review, case reports, QI/PI projects, clinical successes, patient stories, or educational projects. Over 40 student, resident and family physician members attended the virtual conference which was approved for 2.00 AAFP Prescribed CME credits. The event for 2024 is slated for Saturday, November 2nd from 10:00 a.m. – 11:30 a.m.

Choose VA

On May $4^{\rm th}$ the VAFP hosted Choose Virginia 2024 at the Virginia Crossings Hotel & Conference Center in Glen Allen, Virginia. This event was first held back in 2009 in partnership with the Virginia Workforce Development Authority and the Virginia Department of Health.

Over 55 medical students representing all six medical schools and over 40 faculty and family medicine residents from eleven programs across the Commonwealth were in attendance.

Virginia Program/Associate Program Director Engagement

Beginning in July 2023, Virginia Family Medicine Residency Program leadership faculty met on a quarterly basis to share ideas and learn from each other on ways to continue to enhance the training of our future family physicians.

FINANCES

The Virginia Academy of Family Physicians continues its tradition of operating under sound financial leadership. This effort is led by VAFP Treasurer Charles Frazier, MD, and the members of the VAFP Executive/Finance Committee. The committee meets each year to develop an operating budget that meets the needs of the Academy yet is very mindful of the fiscal responsibility to the Academy. During the meeting, the committee also reviews the Academy's Financial Reserve Policy and Statement of Cash.

Currently, the VAFP's dues are among the lowest in the country as compared to other AAFP Chapters with an active membership of similar size. In the last 30 plus years, the Academy has only had four dues increases.

Net income for fiscal year 2023 was \$71,667, which exceeded the budgeted projections by just over \$50,000. The VAFP ended fiscal year 2023 with Net Assets of just over \$2,260,000.

Immunization Updates

The CDC's Advisory Committee on Immunization Practices (ACIP) met from June 26-28 and unanimously (11-0) approved the following recommendations*:

RSV Vaccines -

- Adults 75 years of age and older receive a single dose of RSV vaccine.
- Adults 60–74 years of age and older who are at increased risk of severe RSV disease receive a single dose of RSV vaccine.**

Influenza Vaccines -

- Routine annual influenza vaccination of all persons aged ≥6 months who do not have contraindications.
- High-dose inactivated (HD-IIV3) and adjuvanted inactivated (alIV3) influenza vaccines as acceptable options for influenza vaccination of solid organ transplant recipients younger than 65 years.

COVID-19 Vaccines -

 2024-2025 COVID-19 vaccines as authorized or approved by FDA in persons ≥6 months of age.

Pneumococcal Vaccines -

 PCV21 as an option for adults aged ≥19 years who currently have a recommendation to receive a dose of PCV.

DTaP-IPV-Hib-HepB Vaccines -

 Addition of DTaP-IPV-Hib-HepB (Vaxelis, Merck/Sanofi, MSP) as a preferred product option for vaccination of American Indian and Alaska Native infants

*Insurance coverage of these changes will become effective through the publication of an MMWR in the coming months.

**RSV is not an annual vaccine. Adults who have previously received a dose of an RSV vaccine are NOT recommended to receive another dose

Immunization Pearl

The Hep B vaccination is now universally recommended for adults 19-59 years of age. It is also recommended for adults aged 60 and older with certain risk factors (chronic liver disease, HIV infection, sexual exposure risk, injection drug use, personal or occupational risk for exposure to blood, persons on dialysis, Incarceration. travel in endemic countries) and is a shared-decision-making recommendation for persons with diabetes aged 60 and above.

FAMILY PHYSICIANS SUPPORT FTC RULE TO BAN NON-COMPETES AND IDENTIFY OPPORTUNITIES TO IMPROVE COMPETITION IN HEALTH CARE

Why it matters: The Federal Trade Commission issued a final rule to promote competition by banning non-competes nationwide. As noted in our support for the proposal, noncompete agreements in health care employment impede patient access to care and disrupt care continuity, deter advocacy for patient safety, limit physicians' ability to choose their employers, and stifle competition.

AAFP SHARES RECOMMENDATIONS WITH CONGRESS TO AVOID FUTURE CYBERATTACKS IN HEALTH CARE

Why it matters: The cyberattack on Change Healthcare has had far-reaching implications for family physicians and other providers of health care services, affecting their ability to receive payments and perform everyday business functions that are essential to the delivery of care to patients.

MEDICAID FINAL RULES IMPROVE ACCESS TO CARE

Why it Matters: Medicaid payment rates are typically lower than Medicare rates and vary by state. Payment is one issue that influences clinician participation and beneficiary access in Medicaid. The AAFP urged the Centers for Medicare and Medicaid Services (CMS) to advance proposals to improve rate transparency in both the Medicaid Fee-For-Service (FFS) and Medicaid Managed Care Access rules. The AAFP is pleased that CMS finalized requirements for states to publicly post provider payment rates. This will enable policymakers, clinicians, and other stakeholders to more easily compare Medicare, Medicaid FFS, and Medicaid managed care payments by service and identify disparities.

AAFP APPLAUDS REINTRODUCTION OF LEGISLATION TO STREAMLINE PRIOR AUTHORIZATIONS

The average physician spends two business days completing prior authorizations. The impacts on patient care are jarring, with nearly 97 percent of physicians reporting that their patients experienced delays or denials for medically necessary care due to prior authorization requirements. Congress must pass the Improving Seniors' Timely Access to Care Act to ensure physicians can spend more time treating patients and practicing medicine.

Why it matters: Family physicians are overburdened by prior authorization requirements, which can often cause harmful care delays and inadvertently lead to negative patient outcomes. The AAFP advocates reforming prior authorization and remains focused on enabling physicians and patients to have access to clear guidelines for prior authorization requirements and timely responses from insurance plans.

FAMILY PHYSICIANS RELIEVED SCOTUS PRESERVES PATIENT-PHYSICIAN RELATIONSHIP

Why it matters: The June 13 U.S. Supreme Court decision in the case of Alliance for Hippocratic Medicine (AHM) v. Food and Drug Administration (FDA) preserves the patient-physician relationship and upholds access to mifepristone, an FDA-approved medication. The AAFP has long made clear that patients must be able to depend on their physicians to help them in making critical decisions about their health. Physicians must be able to practice medicine that is informed by their years of medical education, training, and experience and the available evidence.

AAFP ASKS CDC AND FDA TO ENSURE CONTINUED, TIMELY ACCESS TO COVID-19 VACCINES

Why it matters: As we prepare for another COVID-19, flu, and RSV season, it's important that family physicians can provide immunizations to patients in a timely manner. AAFP President Steven P. Furr, MD urged Congress to pass legislation to require Medicare Part B coverage of all recommended vaccines.

MEDICARE PHYSICIAN FEE SCHEDULE PROPOSED RULE SIGNALS NEED FOR SWEEPING PAYMENT REFORM

Why it matters: The Medicare program is essential in helping millions of people access comprehensive, continuous primary care. While the 2025 Medicare physician fee schedule proposed rule includes some proposals to strengthen primary care, its 2.8% reduction in the Medicare conversion factor once again highlights the urgent need for congressional action to ensure that physician payments keep up with the costs of running a practice.

AAFP PROVIDES RECOMMENDATIONS TO CONGRESS ON GME REFORM

Why it matters: The AAFP has long been concerned about the shortage of primary care physicians in the U.S., particularly the supply of family physicians, who provide comprehensive, longitudinal primary care services for patients across the lifespan, including chronic disease management, treatment of acute illnesses, and preventive care.



FAMILY PHYSICIANS SECURE WINS IN FINAL E-PRESCRIBING REGULATIONS

In a win for AAFP advocacy, CMS recently finalized e-prescribing health IT standards and implementation specifications for the Medicare Advantage program and Medicare Prescription Drug Benefit Program. The AAFP applauds CMS for finalizing regulations that will provide enhancements to e-prescribing capabilities, including the ability to communicate with long-term care settings and pharmacies to improve health outcomes. CMS also listened to AAFP recommendations and finalized rules to increase transparency and give physicians a more complete view of patient-specific medication options and costs to select the most clinically appropriate medication at the point of care. The AAFP is also pleased that CMS will now support enhancements that will enable payers to provide additional product-level details about coverage and formulary status.
