Virginia continues to be exceptionally well-positioned to support our members and mission both strategically and operationally. Thanks to the remarkable leadership, engagement, and hard work of our academy, we are fortunate to have a strong and stable foundation that allows

• Dr. Samuel Jones – Virginia Family Physician of the Year Award

Dr. Jones has dedicated over three decades to training the next generation of family physicians, shaping nearly 300 graduates and elevating Fairfax Family Practice into a nationally recognized leader in medical education. Today, Fairfax Family Practice alumni provide nearly 40% of all primary care visits in Fairfax County, a testament to his lasting impact. He recently retired as the President of the Primary Care Service Line for INOVA and continues to see patients and serve on the board for the ABFM Foundation. His influence, both locally and nationally, continues to inspire through his humility, wisdom, and unwavering commitment to our specialty.

• Dr. Augustine Lewis – F. Elliott Oglesby, MD Volunteer of the Year Award

A fourth-generation family physician, Dr. Lewis embodies the heart of our profession through a lifetime of service, from decades of medical mission work across Latin America to his continued dedication at free clinics here in Virginia. Over the years, he has mentored hundreds of medical students and residents, inspiring many to follow in his footsteps whether down the road or across international borders. As a fun fact, Dr. Lewis is also a distant cousin of Merriweather Lewis, of Lewis and Clark. And much like his ancestor, Dr. Lewis has spent his life forging meaningful paths, not through

unexplored territory, but through human connection, care, and healing. His example of humility, compassion, and quiet leadership reminds us all of the true impact of service.

Dr. Elizabeth Polk – James P. Charlton, MD Teacher of the Year Award

Dr. Beth Polk has combined clinical excellence, innovation, and mentorship throughout her career. For over 20 years, she served as a trusted clinician and lead physician at Carilion Daleville Family Medicine. In 2022, she joined the Virginia Tech-Carilion Family Medicine Residency as full-time faculty, expanding her impact through teaching. She created one of the first Lifestyle Medicine board-eligibility tracks in the country, launched a resident lifestyle medicine clinic, and leads efforts in group medical visits. A former Family Medicine Clerkship Director, Dr. Polk has shaped learners across disciplines and is a nationally recognized leader in lifestyle medicine and physician well-being. She serves as Medical Director for Well-being and holds key roles on wellness committees at VTCSOM and VAFP. Whether teaching, leading yoga, or mentoring residents, she brings clarity, compassion, and energy to all she does.

Before I close, I want to share a more personal note. This year, I had the privilege of presenting the President's Award to my wife. While this may not be a traditional choice, we in family medicine understand better than anyone the central role family plays in sustaining us through the demands of this profession. Dear Colleagues,

It is my honor and privilege to serve you as the 79th president of the Virginia Academy of Family Physicians. I am happy to welcome those of you who were able to attend the meeting in person to Virginia Beach - a great place to live, in my opinion, but also a great place to relax and get some high-quality CME credits! I hope that everyone has the opportunity to unwind and spend some quality time with friends and family, and share your new pearls of wisdom with your colleagues when you return to work.

I recall saying when I was an 8-year-old girl that I was going to be a doctor. I may have wavered from that path slightly from time to time, but I set my course in high school and never

looked back. Being only the second physician in my family, when I imagined what a doctor was, I always envisioned a family physician. LEGISLATIVE UPDATE DAVID MAY, JD, MBA, LEGISLATIVE CONSULTANT

Introduction

During the 2025 session of the Virginia General Assembly, the VAFP Legislative Committee, Co-Chaired by Drs. Jesus Lizarzaburu and Mark Watts, Mary Lindsay, Executive Vice President, David May, Legislative Consultant, and all family physician committee members, worked diligently to advocate on behalf of family medicine in Virginia. The Committee met weekly throughout the legislative session and continues to meet during the interim on an as-needed basis or through its list serv. The Committee continues to serve an important role in promoting VAFP's mission and in representing all VAFP members in the legislative arena to ensure that all issues related to primary care, especially those impacting the daily practice of family medicine, are monitored and addressed.

Despite numerous challenges during the 2025 session of the Virginia General Assembly, the VAFP Legislative Committee had yet another successful year. As highlighted below, in advocating for the interests of family medicine, VAFP secured several significant victories in coordination with our colleagues in the House of Medicine.

Medical Malpractice

SB 904 (Stanley) proposed to eliminate the recovery cap on medical malpractice actions brought against health care providers by patients 10 years of age or younger. After advancing from the Senate Courts Committee (8-6-1 vote), VAFP, in coordination with other stakeholders, was able to defeat the bill in the Senate Finance Committee (9-6 vote to pass by indefinitely). Because efforts to remove or increase the recovery cap on medical malpractice claims are likely to reappear, VAFP will continue to advocate on this issue and participate in roundtables that will take place during the interim.

Prior Authorization

VAFP, in consultation with the House of Medicine, successfully supported the passage of three bills related to prior authorization.

HB 2525 (Fowler) requires that the online electronic prior authorization process insurance carriers are required by existing law to establish and maintain beginning July 1, 2025, link directly to real-time patient out-of-pocket costs for prescription drugs. The bill also modifies the requirements and reporting timeline of the work group on electronic prior authorization established by the State Corporation Commission's Bureau of Insurance established by prior legislation.

SB (Pekarsky) and HB 2099 (Maldonado) require certain health insurance contracts under which the insurance carrier has the right to require prior authorization for a health care service to include provisions governing the prior authorization process. Such required provisions include (i) time limits for the carrier's response to prior authorization requests, (ii) a prohibition on revoking, limiting, making conditional, modifying, or restricting a previously approved prior authorization except in certain circumstances, and (iii) a requirement that the carrier provide reasons for denial of a request. The bills require carriers to make publicly available on their website a list of health care services and codes for which prior authorization is required. The bills, which become effective January 1, 2027, also require the State Corporation Commission's Bureau of Insurance to establish a work group to develop and deliver a report related to the bill's provisions by November 1, 2025.

Health Insurance – Claims Payment Method

SB 925 (Head) and HB 2085 (Shin), which also passed with advocacy assistance by VAFP and relevant

stakeholders, help to improve carrier business practices related to methods of payment for claims. Specifically, these bills require insurance carriers to notify providers via contract if the carrier, or entity completing a transaction on behalf of the carrier, uses a payment method that imposes a transaction fee, processing fee, or similar charge on the provider. In situations in which any such fee or charge is to be imposed, the bills also require the carrier to offer the provider an alternative payment method that does not impose such a fee or charge. Moreover, if the provider elects to accept the alternative payment method and has provided all required information to the carrier to enroll in such alternative method, the bills require the carrier to pay the claim using such alternative method.

Scope of Practice – Physician Assistants

After an agreement was reached between MSV and the physician assistants subsequent to the 2024 session, the General Assembly ultimately passed HB 2489 (Henson). This bill directs the Department of Health Professions (DHP) to conduct a study on potential expansion of the scope of practice for physician assistants. In addition to a review of the education and training requirements for physician assistants, the study will include an analysis of the costs and benefits to patients associated with an expansion of the physician assistant scope of practice. DHP is expected to submit its findings and recommendations to the General Assembly by November 1, 2025. The Legislative Committee intends to monitor this study and ensure that VAFP's position on this matter is known and advocated for.

Budget Items

Amid a projected \$636M shortfall at DMAS and a host of other priorities sought during the pressures of an election year; it was a tough year for budget requests. Nevertheless, VAFP continued to zealously advocate for budget items to improve the practice of family medicine in the Commonwealth. These measures included requests for additional funds for the physician loan repayment program and an increase to the Medicaid reimbursement rate. Due to budgetary constraints, we were unable to secure this funding for the current budget cycle; though, we will continue to advocate for improvements in these areas moving forward.

Moreover, despite the aforementioned budgetary constraints, VAFP helped to successfully advocate for other items that were ultimately signed into law. These included a significant bump in funding for the adult psychiatric access line (APAL) and additional funds to support free clinics, which will be used to provide medical, dental, vision, speech, hearing, and behavioral health care, as well as prescription medications and substance use disorder services, to uninsured and underinsured patients.

Looking Ahead

VAFP will continue its advocacy in the General Assembly to support the priorities of family medicine. The Legislative Committee is presently focused on continued defense of scope of practice, implementation of administrative burden reforms, support for family medicine residency programs, and reimbursement improvements in both the public and private sectors. VAFP also continues to place significant focus on achieving Medicare—Medicaid payment parity.

In the midst of significant budgetary constraints and competing opinions and priorities among health professionals and other stakeholders, advocacy by VAFP and its members continues to be of incredible importance. Please consider supporting the FamDocPAC to assist us in promoting and advocating for family medicine in the Commonwealth.

2025 Advocacy Day

VAFP successfully utilized the 2025 session of the Virginia General Assembly as an opportunity to spread awareness of the issues associated with, and the priorities of, family medicine. With more than 60% of the General Assembly members serving their first term, there has been a genuine need for education. As such, VAFP again spent

significant time educating legislators about the ins and outs of primary care.

As part of such advocacy efforts, VAFP sponsored another successful Advocacy Day on Thursday, January 30, 2025. The day began with breakfast and an issue brief from David May, VAFP Legislative Consultant, after which the group headed to the General Assembly Building. With the help of a great turnout by our fearless members, we were able to engage in many face-to-face meetings with legislators and explain our positions on legislation and budget items before the legislature. These efforts not only helped us to develop new relationships and strength existing ties with Delegates and Senators, but also to ensure that all legislators understand and appreciate the importance of primary care in the Commonwealth.

In recognition of these efforts, the feedback we received from legislators was nothing short of amazing. Numerous members made clear that VAFP's presence at the General Assembly Building was not only welcomed, but appreciated. As an example, after our team spoke to Senator Hashmi as a group and took a picture with her outside the Capitol, she reached out to our legislative consultant to reaffirm her appreciation for VAFP's presence and stressed the need for family docs to have a seat at the table as legislators weigh new statutory provisions governing the Commonwealth's health care system.

CONTINUING MEDICAL EDUCATION

The Virginia Academy of Family Physicians continues its tradition of offering first class, affordable continuing medical education conferences for Academy members. The Academy is pleased to report that year 2024-2025 was again very strong in attendance at our CME events. The VAFP CME Committee Chaired by Mitchell Miller, MD, continually works on behalf of family physicians to create events that focus on the most up to date topics that are pertinent to the daily practice of family medicine and national/state educational requirements.

Each year, the Academy sponsors two major CME activities. The Winter Family Medicine Weekend is held over four days in the month of January. The 2025 winter event was held over the dates of January 23-26 at Wintergreen Resort. It drew over 200 family physicians, residents, medical students, and other health care professionals and 38 exhibiting organizations supported the meeting. The Academy continues to offer a one-time complimentary registration to all AAFP member recent graduates that were less than 5 years out of residency. Eight of our new physician members took advantage of this outstanding opportunity.

The Academy's Annual Meeting & Exposition is held each summer in mid-July or early August. This year's Annual Meeting is scheduled for July 10-13 at the Marriott Oceanfront in Virginia Beach. The meeting will be comprised of two full days and two half days of in person general CME sessions and workshops worth over 20 credits of live AAFP Prescribed CME. In 2024, the Academy began offering the VAFP Journal Club as a new session that satisfies the ABFM certification requirements. A special thank you to VAFP Past President and Treasurer Charles Frazier, MD for continuing to facilitate this session in 2025.

In addition to the VAFP Journal Club, the VAFP also sponsored five Knowledge Self-Assessment (KSA) programs to assist VAFP members with the completion of their ABFM Family Medicine certification requirements. These sessions drew maximum attendance and continue to be evaluated very highly. The facilitation of KSA's in a hybrid model has truly been a great membership as it allows members to feel as though they are in person without having to travel if they choose.

New in the year 2024-2025, the VAFP was selected as the educational partner for a program facilitated by the Medical Society of Virginia's Foundation. This new program called the Adult Psychiatric Access Line (APAL), a Project of Health Haven Recovery, is funded by the state's budget and mirrors the current pediatric mental health program, VMAP. Beginning at the 2024 VAFP Annual Meeting, the Academy facilitated lectures, webinars, scholarships and media all focused on mental health and substance use disorder education throughout this past year. The partnership was very successful, and the education extremely well received by VAFP members. The Academy will continue the educational partnership for the 2025-2026 year.

The Academy expresses deep appreciation to the Continuing Medical Education Committee for their outstanding work in creating superb CME for VAFP members and to Kurtis S. Elward, MD, MPH, FAAFP, Mark H. Greenawald, MD, FAAFP, and Charles Frazier, MD, FAAFP for their exceptional work as Family Medicine Certification session presenters.

MEMBERSHIP

As of May 2025, total VAFP membership stood at 3,018 with Active membership totaling 1,752, resident membership at 347 and student membership at 492. Four additional categories including Life membership totaled 427. The membership numbers have slightly decreased from 2024 and an area that the VAFP staff is focused on for the remainder of the year 2025 membership. In evaluating the drop in active membership, the New Physician category (graduation from residency within seven years) and those members that are transitioning from the Active Member to Life Member category show the largest decrease.

Additionally, our resident members decreased slightly and an area that staff will work with program coordinators to strive for 100% resident membership in the VAFP. To help with the decrease in our New Physician members, the VAFP membership voted in 2024 to approve a 25% dues reduction for year two new physicians which adds to the current 50% dues reduction for year one new physicians currently in place. These align with the reductions that the AAFP also made to the national dues structure. The VAFP was also chosen to participate in an AAFP pilot program to obtain personal contact information for all graduating residents so they can be tracked for continued membership either in Virginia or the state in which they practice.

The VAFP continues to offer multiple member benefits including access to the Daily POEMS, the VAFP Career Center and legal resources for employment contract negotiations, regulatory and administrative issues.

Daily POEMs (Patient Oriented Evidence that Matters) from Essential Evidence Plus provide members with complimentary daily alerts and over 3,000 archived POEMs to help members stay abreast of the latest and most relevant medical literature. Delivered directly to by e-mail every Monday through Friday, Daily POEMs identify the most valid, relevant research that may change the way physicians practice. Since 1996, POEMs editors review more than 1,200 studies monthly from more than 100 medical journals, presenting only the best and most relevant as POEMs. The acclaimed POEMs process applies specific criteria for validity and relevance to clinical practice. VAFP's General Counsel, Hunter Jamerson, JD, MBA, continues to partner with the Academy to provide an initial legal resource for VAFP members. The summer of 2024, VAFP welcomed a new Legislative Representative in David May, JD. David's background in legislative services at the Virginia General Assembly is a big win for the Academy's efforts to continue to establish grassroots relationships between legislators and VAFP members. 

RESIDENT, STUDENT & FACULTY

The Virginia Academy of Family Physicians puts great focus on our resident members and student members and the faculty at the residency programs and medical schools that support the training of these future family physicians.

Resident and Student Leadership

VAFP resident and student members can participate in multiple leadership positions at the state level on the VAFP Board of Directors, as members of VAFP committees and as Delegate to the AAFP National Conference representing Virginia. On the national level, as members of AAFP commissions and other various representatives to partner AAFP organizations. On the VAFP Board, resident and medical student representatives serve a one-year term beginning in the fall of each year. Representatives are funded to attend all VAFP Board Meetings as well as the AAFP's National Conference of Family Medicine Residents and Medical Students held annually in July/August.

Resident and Student Benefits

Academy dues are paid by the VAFP for resident members in their first year of residency and all four years of medical student dues are complimentary.

In addition to membership dues benefits, the VAFP provides complimentary housing for students and residents to attend the VAFP Winter Family Medicine Weekend held annually at Wintergreen Resort. At the 2025 VAFP Winter Family Medicine Weekend, 27 Family Medicine Residents and 38 medical students were in attendance. Continued from previous years, was a resident panel discussion that offered students the opportunity to ask questions of residents related to "What It's Like to be a FM Resident?". At the conclusion of the panel discussion, the residents and students enjoyed a complimentary networking dinner.

VAFP also supports residents with discounted employment contract review by the VAFP's General Counsel and a Career Center that houses multiple job offerings in the Commonwealth. VAFP supports the Family Medicine Interest Group's at each of the six Virginia medical schools with \$500.00 in funding to develop programs that promote Family Medicine.

Choose VA Scholarships

The VAFP Foundation offers a medical student scholarship and a resident scholarship for assistance with education loan repayment. Many medical students and family medicine residents in Virginia have expressed an interest in staying in the Commonwealth after their graduation to complete a family medicine residency or to practice in a medically underserved area.

The VAFP Foundation receives donations from generous members to support this effort to keep our own. In 2025, the Foundation received a larger donation that has made it possible to increase the student scholarship by \$500 and the number of resident scholarships from one to two and from \$3,000 each to \$5,000 each.

A \$3,000 scholarship is available for a graduating medical student that attends a Virginia Residency Program, and two \$5,000 scholarships are available for Virginia PGY-3 Graduating Residents that choose to practice in an underserved area of Virginia. The Foundation awarded its first scholarships in 2017.

Research

In the fall of 2024, the VAFP hosted a Scholarly Symposium for residents, medical students, and fellows. This one-day event showcased scholarly work in the areas of clinical or population health research, medical education research, literature review, case reports, QI/PI projects, clinical successes, patient stories, or educational projects. Over 40 student, resident and family physician members attended the virtual conference which was approved for 1.50 AAFP Prescribed CME credits. The event for 2025 is slated for Saturday, November 8th from 10:00 a.m. – 11:30 a.m.

Choose VA

On May 17th the VAFP hosted Choose Virginia 2025 at the Delta Hotel in Richmond, Virginia. This event was first held back in 2009 in partnership with the Virginia Workforce Development Authority and the Virginia Department of Health. Over 45 medical students from Virginia, surrounding states and Caribbean medical schools and over 40 faculty, staff and family medicine residents from twelve programs across the Commonwealth were in attendance. Choose VA offers medical students a firsthand look into what it's like to be a family physician with introductions to Virginia's family medicine residency program faculty and residents as well as multiple procedural sessions for that clinical experience.

Virginia Program/Associate Program Director Engagement

The Virginia Family Medicine Residency Program leadership faculty continues to meet on a quarterly basis to share ideas and learn from each other on ways to continue to enhance the training of our future family physicians.

FINANCES

The Virginia Academy of Family Physicians continues its tradition of operating under sound financial leadership. This effort is led by VAFP Treasurer Charles Frazier, MD, and the members of the VAFP Executive/Finance Committee. The committee meets each year to develop an operating budget that meets the needs of the Academy yet is very mindful of the fiscal responsibility to the Academy. During the meeting, the committee also reviews the Academy's Financial Reserve Policy and Statement of Cash.

Currently, the VAFP's dues are among the lowest in the country as compared to other AAFP Chapters with an active membership of similar size. In the last 30 plus years, the Academy has only had four dues increases.

In the fall of 2024, the Academy created an Investment Policy Committee guided by an Investment Policy Statement that enhances the Academy's long-term strategy of investing cash reserves in strategic instruments including certificates of deposit and a portfolio comprised of investment vehicles that are well diversified, with reasonable expense ratios.

Net income for fiscal year 2024 was \$111,297 which exceeded the budgeted projections by just over \$67,500. The VAFP ended fiscal year 2024 with Net Assets of just over \$2,371,000.

WELLBEING COMMITTEE REPORT

The VAFP Well-being Committee, co-chaired by VAFP Past Presidents Mark Greenawald, MD and Neeta Goel, MD met quarterly via zoom over the course of the last year specifically addressing issues that were derived from the results of the well-being survey and educational topic suggestions from CME event attendees. In the spring of 2025, Dr. Greenawald stepped down as Co-Chair and committee member Andreya Risser, MD, joined Dr. Goel as committee Co-Chair.

The committee addressed multiple topics over the course of the quarterly meetings with specific action related to educational topic suggestions for the VAFP CME Committee, continued Well-being Corner articles in the VAFP magazine, and heard updates on the Joy in Healthcare collaborative which includes five participating organizations (Bon Secours Richmond, Carilion, Ballad, CHKD and Trusted Doctors). Currently the committee is working with VAFP leadership on an all-member needs survey.

The CME sessions focused on well-being were very well received at the 2025 Winter Family Medicine Weekend. Drs. Charlie Frazier, Riverside; Robin Anderson, Sentara; and Marcus Speaker, Carilion presented an interactive session on EHR and AI and Committee Co-Chair Andreya Risser, MD facilitated the closing session titled Wellness in Medicine. Slated for the 2025 Annual Meeting is a Part II session on EHR and AI again presented by Drs. Frazier, Anderson and Speaker and a closing session facilitated by Committee Member Beth Polk, MD titled, "Thriving in Our Professional Ecosystem: Integrating the 5 Factors of Wellbeing into Real World Practice".
